The following agenda items were discussed and approved.

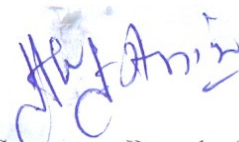
1. More names of external examiners of Ph.D. degree viva voce examination to be added in the existing list were presented and approved
