

Subject: **PROCEEDINGS OF AFFILIATION COMMITTEE MEETING HELD ON 07.11.2023 REGARDING APPEAL OF DIRECTOR BI-KAT**

With reference to the subject cited above, it is to apprise that the Competent Authority (viz. Vice Chancellor) has been pleased to approve the following recommendations of the affiliation committee in its meeting held on 07.11.2023:

1. The committee uphold earlier decision to stop further intake of the said institute till further orders.
2. The representative of BI-KAT Mr. Manzoor Ahmad have made commitment to submit pending papers/examination material till 13.11.2023 otherwise necessary action will be taken as per HEC/University rules.
3. The committee also decided to uphold the decision regarding transfer of enrolled students to any other institute of their own choice, however, incase if any student himself/herself willing to continue their studies at BI-KAT, the university authorities will not be responsible for any anomalies arises regrading conduct of classes and examinations by BI-KAT, non-submission/announcement of results and non-completion of degree within stipulated time period (residency period) or teacher shortage etc.
4. The committee also uphold earlier decision regarding visit to the said institute after six months with HEC nominee for further recommendation/consideration.
5. The committee also decided to register their 11 students of BBA (2 Year) admitted in Spring semester 2023 if all the codel formalities are fulfilled by the BI-KAT otherwise, university administration will not be responsible for any delay or cancelation of their admission.
6. The representative of BI-KAT Mr. Manzoor Ahmad has also directed to submit outstanding dues at the earliest along with fine as already decided.

Therefore, it is required to take necessary action as per recommendations of the affiliation committee mentioned here in above.


